**We are enclosing for your information a copy of our regulations concerning the availability of GAO records to the public which are contained in 4 C.F.R. Part 81 (2003).**


**We searched our files and located the following documents related to Mr. Kirk's assignment:**

**We are enclosing item 1. We decline to release items 2 and 3 on the basis of 4 C.F.R. § 81.6(a), which states that congressional correspondence and other records relating to work performed in response to a congressional request and congressional contact memoranda are exempt from disclosure.**

In accordance with 4 C.F.R. § 81.4(d), further consideration of your request—to the extent that it has been denied—may be obtained by an appeal letter to the Comptroller General of the United States setting forth the basis for your belief that the partial denial of your request is unwarranted.
